**ORDINANCE NO. 7585**

**AN ORDINANCE  
AMENDING TITLE XI, CHAPTER 119  
OF THE LOMBARD VILLAGE CODE IN REGARD TO  
RESTAURANTS AND FOOD**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title XI, Chapter 119, Section 119.01 of the Lombard Village Code is amended to read in its entirety as follows:

**§ 119.01 Food Handler Definition.**

For purposes of this Chapter, the term “food handler” shall be defined the same as the term “food establishment,” as found in Section 18-201 of the DuPage County, Illinois County Code.”

**SECTION 2:** That Title XI., Chapter 119, Section 119.02(B) of the Lombard Village Code is amended by revising the word “restaurant,” as contained therein, to read “food handler.”

**SECTION 3:** That Title XI., Chapter 119, Section 119.12 of the Lombard Village Code is amended by revising the term “food dealer,” as contained therein, to read “food handler.”

**SECTION 4:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
