ARTICLE I – DEFINITIONS

Section 10-1-1 Definitions

The defined terms and definitions, as set forth in the Illinois Vehicle Code, which is adopted by reference pursuant to Section 10-19-1 of this Lombard Traffic Code, shall, when used in this Lombard Traffic Code, have the meanings ascribed to them in the Illinois Vehicle Code.

ARTICLE II - APPLICATION OF THE TRAFFIC LAWS PROVIDED FOR IN THE LOMBARD TRAFFIC CODE

Section 10-2-1 Provisions Refer to Vehicles upon the Highways-Exceptions.

The provisions of the Ordinance relating to the operation of vehicles refer exclusively to the operation of vehicles upon highways except:

1. Where a different place is specifically referred to in a given section.
2. The provisions of Article V shall apply upon highways and elsewhere throughout the Village.

ARTICLE III - TRAFFIC SIGNS, SIGNALS, AND MARKINGS

Section 10-3-1 Duties of the Director of Public Works and Buildings with respect to traffic

It shall be the duty of the Director of Public Works and Buildings to determine the installation and proper timing and maintenance of traffic-control devices, to conduct engineering analyses of traffic accidents and to devise remedial measures, to conduct engineering investigation of traffic conditions, to plan the operation of traffic on the streets of this Village, including parking areas, and to cooperate with other Village officials in the development of ways and means to improve traffic conditions and to carry out the additional powers and duties imposed by ordinances of this Village.

Section 10-3-2 Standing and temporary regulations

(a) The Chief of Police by and with the approval of the Director of Public Works and Buildings is hereby empowered to make regulations necessary to make effective the provisions of the Ordinance and to make and enforce temporary or experimental regulations to cover emergencies or special conditions. No such temporary or experimental regulation shall remain in effect for more than 30 days.

(b) The Director of Public Works and Buildings may test traffic-control devices under actual conditions of traffic.

Section 10-3-3 Traffic Control Devices

The Village hereby adopts by reference the provisions of the most recent edition of the National Manual on

Uniform Traffic Control Devices for Streets and Highways, as published by the federal government, and the most recent edition of A Policy on Geometric Design of Highways and Streets, as published by the American Association of State Highway and Transportation Officials, for purposes of establishing guidelines for the installation and governance of traffic control devices within the Village. At least one (1) copy of each of the foregoing publications shall at all times be on file with the Village Clerk.

ARTICLE IV - (RESERVED)

ARTICLE V - DRIVING WHILE UNDER THE INFLUENCE

Section 10-5-1 Driving While Under the Influence

(a) The following provisions of the Illinois Vehicle Code, 625 Illinois Compiled Statutes, 625 ILCS 5/1-100 et seq., as may be amended from time to time, are hereby adopted by reference pursuant to the authority granted in 625 Illinois Compiled Statutes 5/20-204:

Section 11-501, 11-501.1, 11-501.2, 11-501.4, 11-501.4-1, 11-501.5, 11-501.6, 11-501.7, and 11-501.8, excepting Section 11-501(d).

(b) The court, upon making a finding of guilty for any offense under section 10-5-2 of this Article, in addition to any sentencing alternative elected by the court, shall impose a fine of not less than one thousand dollars (\$1,000.00) for each such offense. In the event that the Illinois Vehicle Code imposes a minimum fine greater than one thousand dollars (\$1,000.00) for such an offense, the greater of the statutory minimum fine or one thousand dollars (\$1,000.00) shall be imposed.

ARTICLE VI - SPEED RESTRICTIONS

Section 10-6-1 Speed restrictions

As authorized by law, it is hereby determined, upon the basis of an engineering and traffic investigation, that the reasonable and safe maximum speed limits on certain designated streets or highways, or portions of streets or highways, within the Village should be and are hereby established as provided in Schedule I attached hereto and made part hereof.

Section 10-6-2 Emergency vehicles

The speed limits established by this Article or by regulation or ordinance made pursuant to the provisions of this Article do not apply, except as otherwise provided in "An Act Relating to the Operation of Ambulances," State of Illinois, enacted by the Seventy-Third General Assembly, to an authorized emergency vehicle in motion when responding to an emergency call and when the driver thereof sounds an audible signal by bell, siren, or exhaust whistle, as may be reasonable necessary, provided that the vehicle is equipped and has in operation at least one lighted lamp displaying an oscillating rotating, or flashing red beam. An authorized emergency fire department vehicle may be equipped and have in operation a triple eight moving white beam light visible under normal atmospheric conditions from a distance of 500 feet to the front of such vehicle, in lieu of, or in addition to, a rotating or flashing red beam, in order to be exempt from the speed limits established by this Article. No other

authorized emergency vehicle shall use any oscillating triple eight moving white beam other than a fire department vehicle. However, the provision does not relieve the driver of an authorized emergency vehicle from the duty to drive with due regard for the safety of all persons using the street, nor does it protect the driver of any such vehicle from the consequences of a reckless disregard of the safety of others.

Section 10-6-3 Special speed restrictions - school zones

(a) No person shall drive a motor vehicle at a speed in excess of twenty miles per hour while passing a school zone or while travelling upon any public thoroughfare on or across which school children pass going to and from school during school days when school children are present.

(b) This section shall not be applicable unless appropriate signs are posted upon streets and highways within the Village of Lombard wherein such school zone is located. Such signs shall give proper due warning that a school zone is being approached and shall indicate the school zone and the maximum speed limit in effect during school days when school children are present.

(c) The provisions of this section, when applicable, shall be paramount to any other speed restrictions established by this Ordinance and shall not be deemed to be in conflict therewith.

Section 10-6-4 Violations - charges

In every charge of violation of Section of this Article by failure to observe an applicable speed limit, the complaint and also the summons or notice to appear shall specify the speed at which the defendant is alleged to have driven, and the speed limit which is applicable at the place of the alleged violation.

Section 10-6-5 Traffic Regulation in Construction Zones and the Detour Routes in Relation thereto.

(A) It shall be unlawful for any person to drive any vehicle through a designated construction zone, or on the right-of-ways comprising the detour route in relation thereto, at a speed in excess of the maximum speed posted by sign relative to said designated construction zone or the detour route in relation thereto.

(B) It shall be unlawful for any person to park a vehicle on any street designated by posted signs as a detour route in relation to a construction zone, provided said detour route is also posted with signs indicating that parking is prohibited.

(C) For purposes of this Section, a designated construction zone shall be defined as an area within the public right-of-way in which construction activity is taking place, that is clearly marked with signs indicating it to be a designated construction zone with a specified posted speed limit.

(D) For purposes of this Section, a detour route in relation to a designated construction zone shall be defined as those public right-of-ways that are clearly marked with signs indicating that they are being used as a detour route with a specified posted speed limit.

(E) The speed limit posted for any designated construction zone, or detour route in relation thereto, shall be determined by the Police Chief and the Director of Public Works, taking into account the nature of the construction work, the normal posted speed limit for the roadway in question, the volume of traffic driving

through the area and the proximity of the construction to the motor vehicles driving by. In no event, however, shall the posted speed limit in a construction zone, or a detour route in relation thereto, be less than fifteen (15) miles per hour.

(F) In relation to a detour route, the Police Chief and the Director of Public Works shall, take into account the volume of traffic that will be using the detour route, have the authority to post intersections along the detour route as stop or yield intersections, so as to protect the health, safety and welfare of the residents residing along said detour route and the occupants of the vehicles traveling along the detour route. Unless approved by an Ordinance adopted by the President and Board of Trustees, any such stop or yield signs shall be removed at such time as the intersection in question is no longer part of a detour route. It shall be unlawful for any person to drive a vehicle through an intersection controlled by a stop sign or yield sign posted pursuant to this subsection without bringing said vehicle to a full and complete stop, or yielding to cross traffic, depending on the sign posted, before proceeding through said intersection.

(G) Any person found to be in violation of Subsection B above shall be fined not less than one hundred fifty and no/100 dollars (\$150.00) nor more than seven hundred fifty and no/100 dollars (\$750.00), exclusive of Court costs and fees.

(H) Any person found to be in violation of Subsection A above shall be fined not less than two hundred fifty and no/100 dollars (\$250.00) nor more than seven hundred fifty and no/100 dollars (\$750.00), exclusive of Court costs and fees, for a first violation. Any person found to be in violation of Subsection A above a second or further time shall be fined not less than seven hundred fifty and no/100 dollars (\$750.00), exclusive of Court costs and fees.

ARTICLE VII – (RESERVED)

ARTICLE VIII - TURNING MOVEMENTS AND DRIVER'S TURNING SIGNALS

Section 10-8-1 Required position and method of turning at intersections

The driver of a vehicle intending to turn at an intersection shall do so as follows:

(a) Both the approach for a right turn and a right turn shall be made as close as practical to the right hand curb or edge of the roadway.

(b) At any intersection where traffic is permitted to move in both directions on each roadway entering the intersection an approach for a left turn shall be made in that portion of the right half of the roadway nearest the center line thereof and by passing to the right of such center line where it enters the intersection and after entering the intersection the left turn shall be made so as to leave the intersection to the right of the center line of the roadway being entered. Whenever practicable the left turn shall be made in that portion of the intersection to the left of the center of the intersection.

(c) At any intersection where traffic is restricted to one direction on one or more of the roadways, the driver of a vehicle intending to turn left at any such intersection shall approach the intersection in the extreme left-hand lane lawfully available to traffic moving in the direction of travel of such vehicle, and after entering the intersection the left turn shall be made so as to leave the intersection, as nearly as practicable, in the left hand lane lawfully available to traffic moving in such direction upon the roadway being entered.

Section 10-8-2 Turning on crest of hill

No vehicle shall be turned so as to proceed in the opposite direction upon any curve, or upon the approach to, or near the crest of a grade, where such vehicle cannot be seen by the driver of any other vehicle approaching from either direction within 500 feet.

Section 10-8-3 Driver's signal

(a) No person shall turn a vehicle from a direct course upon a highway unless and until such movement can be made with reasonable safety and then only after giving a clearly audible signal by sounding the horn if any pedestrian may be affected by such movement or after giving an appropriate signal in the manner hereinafter provided in the event any other vehicle may be affected by such movement.

(b) A signal of intention to turn right or left shall be given during not less than the last 100 feet traveled by the vehicle before turning.

(c) No person shall stop or suddenly decrease the speed of a vehicle without first giving an appropriate signal in the manner provided herein to the driver of any vehicle immediately to the rear when there is opportunity to give such signal.

(d) Any stop or turn signal when required herein shall be given either by means of the hand and arm or by a signal lamp or lamps or mechanical signal device, except as otherwise provided in paragraph (e).

(e) Any motor vehicle in use on a highway shall be equipped with, and required signal shall be given by, a signal lamp or lamps or mechanical signal device when the distance from the center of the top of the steering post to the left outside limit of the body, cab, or load of such motor vehicle exceeds 24 inches, or when the distance from the center of the top of the steering post to the rear limit of the body or load thereof exceeds 14 feet. The latter measurement shall apply to any single vehicle, also to any combination of vehicles.

(f) All signals herein required given by hand and arm shall be given from the left side of the vehicle in the following manner and such signals shall indicate as follows:

1. Left turn - Hand and arm extended horizontally.
2. Right turn - Hand and arm extended upward.
3. Stop or decrease of speed - Hand and arm extended downward.

Section 10-8-4 "U" Turns

It shall be unlawful for the operator of any vehicle to make a U-Turn as defined herein upon any public street or alley, providing such public street or alley has signs posted prohibiting U-Turns.

ARTICLE IX - RIGHT OF WAY

Section 10-9-1 Vehicle entering through street, stop intersection, or stop crosswalk

(a) The driver of a vehicle shall stop at the entrance to a through street, as defined herein, and shall yield the right-of-way to the other vehicles which have entered the intersection from said through street or which are approaching so closely on said through street as to constitute an immediate hazard, but said driver having so yielded may proceed at such time as a safe interval occurs.

(b) The driver of a vehicle shall likewise stop in obedience to a stop sign as required herein at an intersection where a stop sign is erected at one or more entrances thereto although not a part of a through street and shall proceed cautiously, yielding to vehicles not so obliged to stop which are within the intersection or approaching so closely as to constitute an immediate hazard, but they may proceed.

(c) Where stop signs or flashing red signals are in place at an intersection or at a plainly marked crosswalk between intersections, drivers of vehicles shall stop before entering the nearest crosswalk and pedestrians within or entering the crosswalk at either edge of the roadway shall have the right-of-way over vehicles so stopped. Drivers of vehicles having so yielded the right-of-way to pedestrians entering or within the nearest crosswalk at an intersection shall also yield the right-of-way to pedestrians within any other crosswalk at the intersection.

Section 10-9-2 Through Streets

Every driver of a vehicle traversing any street intersecting with any through street are heretofore or hereafter established shall stop such vehicle as required in Section 10-9-1(a) before entering upon the through street, unless otherwise directed at such intersection by a police officer or traffic control signal.

Those streets and parts of streets described in Schedule II, attached hereto and made part hereof, are hereby declared to be through streets for the purpose of this Section.

Section 10-9-3 Stop Intersections

Except when directed to proceed by a police officer or traffic control signal every driver of a vehicle approaching a stop intersection as defined herein shall stop as required by Section 10-9-1(b). Those intersections and parts of intersections described in Schedule III, attached hereto and made part hereof, are hereby declared to be stop intersections for the purpose of this Section.

Section 10-9-4 Stop streets

Every driver of a vehicle proceeding upon a stop street as herein defined shall stop as required in Section 10-12-1. Those streets or portions of streets described in Schedule IV, attached hereto and made part hereof, are hereby declared to be stop streets at the intersections, entrances or points designated therein for the purpose of this Section.

Section 10-9-5 Preferential streets

Except when directed to proceed by a police officer, every driver of a vehicle in approaching a preferential street as herein, defined and in obedience to a yield sign, shall reduce the speed of his vehicle to not more than twenty miles per hour and shall yield the right-of-way to vehicles upon the preferential street which have entered the intersection either from the right or left, or which are approaching so closely as to constitute an immediate hazard; but the driver, having so yielded, may proceed at such time as a safe interval occurs. Those streets or portions of streets described in Schedule V, attached hereto and made part hereof, are hereby declared to be preferential streets at the intersections or entrances designated therein for the purpose of this Section.

Section 10-9-6 One-way streets

Upon a roadway designated and sign posted for one-way traffic a vehicle shall be driven only in the direction designated. Those streets and portions of streets described in Schedule VI, attached hereto and made part hereof, are hereby declared to be one-way streets for the purpose of this Section.

ARTICLE XII - SPECIAL STOPS REQUIRED

Section 10-12-1 For stop signs

Every driver of a vehicle approaching a stop sign shall stop before entering the crosswalk on the near side of the intersection or in the event there is no crosswalk shall stop at a clearly marked stop line, but if none, then at the point nearest the intersecting roadway where the driver has a view of approaching traffic on the intersecting highway before entering the intersection, except when directed to proceed by a police officer or a traffic signal.

ARTICLE XIII - STOPPING, STANDING AND PARKING

Section 10-13-1 Parking prohibited in specific places

(a) No person shall park a vehicle, except when necessary to avoid conflict with other traffic or in compliance with the directions of a police officer, in any of the following places:

1. On a sidewalk;
2. In front of a public or private driveway;
3. Within an intersection;
4. Within 15 feet of a fire hydrant;
5. On a crosswalk;
6. Within 20 feet of a crosswalk at an intersection;
7. On a parkway, except as otherwise provided herein;
8. Within 30 feet upon the approach to any flashing beacon, stop sign, or traffic-control signal

- located at the side of a roadway;
- 9. Within 50 feet of the nearest rail or a railroad grade crossing;
- 10. Within 20 feet of the driveway entrance to any fire station and on the side of a street opposite the entrance to any fire station within 75 feet of said entrance when properly sign posted;
- 11. Alongside or opposite any street excavation or obstruction when such parking would obstruct traffic;
- 12. On the roadway side of any vehicle parked at the edge or curb of a street;
- 13. Upon any bridge or other elevated structure upon a highway or within a highway tunnel;
- 14. Within 50 feet in either direction of main entrances to any public building, public library, theatre, building used for public assembly, church, or parochial school; provided that it shall be unlawful to park any vehicle for a period of time longer than three minutes for loading and unloading of property within said 100 feet zone;
- 15. Upon municipally owned or leased property excepting alleys and streets not metered or designated by posted signs as being for public parking, unless the vehicle displays an authorized Village parking emblem registered and issued to Village employees by the Village Clerk.
- 16. Upon municipally owned or leased property designated by posted signs as "Visitor Parking" except while actually having or carrying on bona fide business with the Village during the time the vehicle is parked within said designating area;
- 17. On any private property without the consent of the owner of the private property.

(b) No person shall park a vehicle, or a specifically identified type of vehicle, as the case may be, except when necessary to avoid conflict with other traffic or in compliance with the directions of a police officer, at any place where official signs prohibit parking upon those streets or portions of streets described in Schedules VII, XX, XXI and XXII, attached hereto and made part hereof

Section 10-13-1.1 Presumption that registered owner parked vehicle

Whenever any vehicle shall have been parked in violation of the provisions of any ordinance prohibiting or restricting parking, the person in whose name such vehicle is registered shall be prima facie responsible for such violation and subject to the penalty thereof.

Section 10-13-2 Officers authorized to remove or impound illegally parked vehicles

(a) Whenever any police officer finds a vehicle parked upon a highway in violation of any of the provisions of Section 10-13-1, such officer is hereby authorized to move such vehicle, or require the driver or other person in charge of the vehicle to move the same, to a position off of such highway.

(b) Police officers are hereby authorized to provide for the removal of a vehicle from a street or highway to the nearest garage or other place of safety or to a garage designated or maintained by the Village under the circumstances hereinafter enumerated.

- 1. When any vehicle is left unattended upon any bridge or cause way or in any tunnel where such vehicle constitutes an obstruction traffic.
- 2. When a vehicle upon a street is so disabled as to constitute an obstruction to traffic and the person or persons in charge of the vehicle are by reason physical injury incapacitated to such an extent as to be unable to provide for its custody or removal.

3. When any vehicle is left unattended upon a street and is so parked illegally as to constitute a definite hazard or obstruction to the normal movement of traffic.
4. When a vehicle is found being driven upon the streets and is not in proper condition to be driven.
5. When a vehicle is left unattended upon a street continuously for more than 48 hours and may be presumed to be abandoned
6. When the driver of such vehicle is taken into custody by the Police Department and such vehicle would thereby be left unattended upon the street.
7. When removal is necessary in the interest of public safety because of fire, flood, storm, snow or other emergency reason.

(c) No person other than a police officer, as provided in this section, shall move a vehicle into any prohibited area or away from a curb such a distance as is unlawful or start or cause to be started the motor of any motor vehicle, or shift, change, or move the levers, brake, starting device, gears, or other mechanisms of a parked motor vehicle to a position other than that in which it was left by the owner or driver thereof, or attempt to do so.

Section 10-13-3 Parking prohibited during certain hours on certain streets

When signs are erected giving notice thereof, no person shall park a vehicle, except when necessary to avoid conflict with other traffic or in compliance with the directions of a police officer, between the hours specified in Schedule VIII, attached hereto and made part hereof, upon any of the streets or portions of streets described in Schedule VIII for the purpose of this Section

Section 10-13-4 Parking prohibited during certain hours on Sunday

When signs are erected giving notice thereof, no person shall park a vehicle, except when necessary to avoid conflict with other traffic or in compliance with the directions of a police officer, between the hours specified in Schedule IX, attached hereto and made part hereof, on Sundays, upon any of the streets or portions of streets described in Schedule IX for the purpose of this Section.”

Section 10-13-5 Parking at right-hand curb and upon parkways

(a) Where angle parking is not permitted every vehicle stopped or parked upon a roadway where there is an adjacent curb shall be so stopped or parked with the right-hand wheels of such vehicle parallel with and within 12 inches of the right-hand curb.

(b) Upon a parkway where parking is permitted as indicated by appropriately posted signs or by space specially provided therefore by the Village authorities, vehicles shall not be parked upon the adjacent roadway.

Section 10-13-6 Angle parking

No person shall park any vehicle in an area marked for angle parking in any manner other than designated by such marking.

Section 10-13-7 Vehicles for sale

It shall be unlawful to park any vehicle upon any street or highway, or in any quasi public parking lot within fifty (50) feet of the right of way of any street or highway, for the primary purpose of sale, within the Village of Lombard.

"Primary purpose of sale" means; the vehicle is parked with signs or markings clearly indicating that the vehicle is offered for sale and that said vehicle is not being used for any purpose other than offering the vehicle for sale.

It is presumed, in the event a vehicle is parked in excess of ten (10) hours at one (1) location with signs indicating the vehicle is for sale, that the primary purpose is for sale purposes.

Quasi public parking lots means any off street parking area designated for the use of the general public who have business or some other type of function at the premises where the parking lot is located.

Any person who shall violate any provision of this ordinance relating to parking within fifty (50) feet of a right-of-way shall upon convictions thereof be subject to a fine of not less than \$50.00 nor more than \$500.00 for each offense. The Police Department need not commence prosecution proceeding against any violator who appears at the Lombard Municipal Building and pays the sum of \$20.00 to the Village or deposits the violation notice and sum of \$20.00 in the U.S. mail to the Village of Lombard or in the Village Bill box posted for this purpose, no later than 72 hours after the violation time indicated by the officer issuing the violation notice. Any violator who does not pay the sum of \$20.00 within 72 hours in order to avoid prosecution, may present the violation notice and pay the sum of \$30.00 to the Village no later than seven (7) days following the violation.

Any vehicle which has been parked and has received notice of violation of said parking of more than five (5) days may be towed by the Lombard Police Department after proper notice has been sent to the last owner of record certified mail or personal service. The party shall have the opportunity of requesting a hearing with one (1) business working day in order to make a determination as to whether or not said vehicle should be towed. Any costs associated with the towing of the vehicle and/or storage shall be the responsibility and liability of the vehicle owner.

Section 10-13-8 Loading zones and public alleys

It shall be unlawful for the driver of a vehicle to stand a passenger vehicle for a period of time longer than is necessary for the loading or unloading of passengers, not to exceed three minutes, and for the driver to stand any freight carrying vehicle for a period of time longer than is necessary to load, unload, and deliver materials, not to exceed thirty minutes, in any public alley or loading zone.

Section 10-13-9 Night parking restriction

It shall be unlawful for any person, except physicians on emergency calls, to park a vehicle on any

street or parkway for a period of time longer than fifteen minutes between the hours of 2:00 a.m. and 5:00 a.m.; provided further that such vehicles so parked must have the parking lights illuminated.

Section 10-13-10 Parking time limited on certain streets

When signs are erected giving notice thereof, no person shall park a vehicle upon any of the streets or portions of streets described in Schedule X, attached hereto and made part hereof, for a period of time longer than that specified in said Schedule X for the purpose of this Section

Section 10-13-11 Cab Stands - Bus Zones - Village Vehicle Zones

No vehicle other than a licensed taxicab, bus or a Village-owned vehicle shall be parked in any of the areas designated respectively as a taxicab stand, a bus loading zone or a Village vehicle parking zone in Schedule XI, attached hereto and made part hereof, for the purpose of this Section

Section 10-13-12 Parking limited during snow removal

(A) It shall be unlawful to park any vehicle for a period of time longer than three minutes for loading and unloading of passengers or thirty minutes for loading and unloading of property of any street at any time after snow begins to fall and for a period of eight hours after snow ceases to fall, if the snow on the street exceeds one inch (1") in depth, as determined by the Director of Public Works or his representative, and for such added period of time, if necessary, to complete snow removal operations on any such street(s).

(B) For parking restrictions relative to municipal parking lots after a snowfall of one (1) inch or more, see Section 10-13-24(B) of this Traffic Code.

The Director of Public Works, or his representative, shall immediately notify the media and Police Department when he determines that snow on any street within the Village limits exceeds one inch (1") in depth.

Any person, firm or corporation violating the provisions of this Section shall be fined not less than Twenty-five (\$25.00) Dollars for each offense.

Section 10-13-13 Illegally stopped vehicles

No person driving or in charge of a motor vehicle shall permit it to stand unattended without first stopping the engine, locking the ignition and removing the key, or when standing upon any perceptible grade without effectively setting the brake thereon and turning the front wheels to the curb or side of the highway.

Section 10-13-14 Daily Parking Fees and Time Limits; Use of Proceeds

- (a) The fee to park in a daily fee parking lot shall be \$1.50 per day, said fee to be paid upon use of the space during the designated hours below. The payment of daily parking fees shall be required between the hours of 5:00 a.m. and 11:00 a.m., except Saturdays, Sundays and holidays; provided, however, that for purposes of this Section the term holiday shall include only the following days: the first day of January, the fourth Monday of May, the fourth day of July, the first Monday in September, the fourth Thursday in November and the twenty-fifth day of December.
- (b) The daily parking fee is required and shall be used to defray the expense of property regulation of traffic upon the public streets of the Village of Lombard; to provide for the cost of supervision, regulation and control of the parking of vehicles in the parking lots; and to cover the cost of purchase, supervision, protection, inspection, installation, operation, maintenance, control and use of the parking system.

All fees shall be kept in a separate account. The money in the account shall be used for the purpose of operating and maintaining all daily fee parking lots. Any balance in this account shall be used only for the acquisition, equipment and maintenance of all off street parking areas, for the permanent alleviation of traffic congestion in the Village, and for the construction of improvements to traffic conditions.

Section 10-13-15 Parksafes zones

Parksafes zones, as defined in Section 10-1-1 hereof, are established upon those streets, or portions of streets and such other designated areas as described in Schedule XII hereof.

Section 10-13-16 Installation of Parksafes System

The parksafes collection boxes shall be installed in an area as close as possible to the parking meter zones. Each collection slot shall be clearly marked as to which parking space it relates to.

Section 10-13-17 Marking parking places

The Director of Public Works and Buildings shall provide for the placing or painting of markings upon the curb and/or upon the street adjacent to each parksafes system for the purpose of designating the parking space for which said parksafes system is to be used and each vehicle parking adjacent or next to any parksafes system shall park within the lines or marking so established. It shall be unlawful to park any vehicle across any such line or marking or to park said vehicle in such a position that the same shall not be entirely within the area so designated by such line or marking. Obliteration or obscuring of such lines shall not invalidate the provisions of this section.

Section 10-13-18 Regulations applicable to the parksafes system

It shall be unlawful and a violation of the provisions of this Ordinance for any person:

- (a) To cause, allow, permit or suffer any vehicle registered in the name of, or operated by such person to be parked overtime, or beyond the period of legal parking time established for any parksafes zone as herein described, or to deposit in any parksafes system any coin for the purpose of parking beyond the maximum legal parking time for the particular parksafes zone.

(b) To permit any vehicle to remain or be placed in any parking space adjacent to any parksafe system while said system is displaying a signal indicating that the vehicle occupying such parking space has already been parked beyond the period prescribed for such parking space.

(c) To park any vehicle across any line or marking of a parksafe zone or in such position that the vehicle shall not be entirely within the area designated by such lines or markings.

Section 10-13-19 Tampering with meters

It shall be unlawful for any person to deface, injure, tamper with, open or willfully break, destroy, or impair the usefulness of any parksafe system installed under the provisions of this Article.

Section 10-13-19.1 Depositing slugs

It shall be unlawful to deposit or cause to be deposited in any parksafe system, any slug, device or metallic substitute, or any other substitute for any coin.

Section 10-13-20 Parking in fire lane

(a) It shall be unlawful for any person to park in any area designated and posted "No Parking" by the Fire Chief.

(b) The Police Department is authorized to place violation notices on every vehicle parked in violation of this Ordinance, and to cause summonses or warrants to be issued to commence prosecution against violators, except that, where no other penalty is provided, the Police Department need not cause such proceedings to commence against any violator who pays twenty dollars (\$20.00) within seventy-two (72) hours of the time of the violation or thirty dollars (\$30.00) after seventy-two (72) hours of the violation but prior to the commencement to the filing of a complaint with the Clerk of the Court for the Eighteenth Judicial Circuit, DuPage County, Illinois.

(c) Any person who violates Section 10-13-20 (a) shall be fined not less than twenty-five dollars (\$25.00) nor more than five hundred dollars (\$500.00) except as set forth in subsection (c).

Section 10-13-21 Penalty - Procedure in handling violations

A. Any person who shall violate any of the provisions of Section 10-13-18 of this article relating to parking meter zones shall, upon conviction thereof, be subject to a fine of not less than Three Dollars nor more than Two Hundred Dollars for each offense; the Police Department need not commence prosecution proceedings against any violator who appears at the Lombard Municipal Building and pays the sum of Three Dollars (\$3.00) to the Village Collector, or drops the violation notice and Three Dollars (\$3.00) in the Traf-O-Teria box posted for this purpose on the parking meter post no later than seventy-two (72) hours after the violation time indicated by the Officer issuing the violation notice. Any violator who does not pay the sum of Three Dollars (\$3.00) to the Village Collector, or does not deposit the violation notice and Three Dollars (\$3.00) in the Traf-O-Teria box within the seventy-two (72) hours period must, in order to avoid said proceedings, present the violation notice

and pay the sum of Five Dollars (\$5.00) to the Village Collector no later than seven (7) days following the violation.

B. Penalty procedure for parking violations. Any person who violates any of the provisions of the parking ordinances of the Village of Lombard, except for Schedule X-PARKING TIME LIMITED ON CERTAIN STREETS (h), shall upon the conviction thereof be subject to a fine of not less than \$20.00 nor more than \$200.00 for each such offense. The Police Department need not commence prosecution proceedings against any violator who appears at the Lombard Municipal Building and pays the sum of fifteen and no/100 dollars (\$15.00) within 72 hours of the time of the violation or twenty-five and no/100 dollars (\$25.00) after 72 hours of the violation, but prior to the commencement to the filing of a complaint with the Clerk of the Court of the Eighteenth Judicial Circuit, DuPage County, Illinois.

B-1. Penalty Procedure for Parking Violations. Any person who violates Schedule X PARKING TIME LIMITED ON CERTAIN STREETS (h) shall upon the conviction thereof be subject to a fine of not less than \$20.00 nor more than \$200.00 for each such offense.

C. Immobilization of motor vehicles for parking violations shall be in accordance with Title 7, Chapter 72 of the Lombard Village Code.

Section 10-13-22 Municipal parking permits

Except in regard to the special Village Parking Lot A, the North Broadway Avenue parking lot, the East South Broadway parking lot, and the 21 N Park Parking lot, as referenced in Schedule XII (a), it shall be unlawful to park any motor vehicle within any municipal parking lot as described in Schedule XII at any time between the hours of 2:00 a.m. and 5:00 a.m., after snow begins to fall, if the snow within the municipal parking lot is one (1) inch or more in depth, as determined by the Director of Public Works or his representative.

(a) Municipal Parking Permits may be issued to Village residents authorizing the parking of private vehicles in the municipally owned or leased properties described in Schedule XII attached hereto and made part hereof for the purpose of this Section.

(b) Such permits shall be deemed properly displayed when affixed to the rear window of the vehicle.

(c) These permits shall be issued by the Village Clerk with or without fees and for time intervals as determined from time to time by the Board of Trustees.

(d) It shall be unlawful for any privately owned vehicle to be parked in said areas without proper display of a valid Municipal Parking Permit. Penalty for failure to comply with these regulations shall be punishable as provided elsewhere in the Traffic Code.

(e) Vehicles parked in those parking lots referenced in Schedule XII (a) shall be required to display a valid Village of Lombard Municipal Parking Permit between the hours of 5:00 a.m. and 11:00 a.m., except Saturdays, Sundays and holidays; provided, however, that for purposes of this Section the term holiday shall include only the following days: the first day of January, the fourth Monday of May, the fourth day of July, the first Monday in September, the fourth Thursday in November and the twenty-fifth day of December.

(f) Vehicles parked in those parking lots references in Schedule XII (c) shall be required to display a valid Village of Lombard Municipal Resident Parking Permit between the hours of 5:00 a.m. and 11:00 a.m., except Saturdays, Sundays and holidays; provided, however, that for purposes of this Section the term holiday shall include only the following days: the first day of January, the fourth Monday of May, the fourth day of July, the

first Monday in September, the fourth Thursday in November and the twenty-fifth day of December. Parking permits shall be issued only to and valid only when displayed on vehicles displaying a valid Village of Lombard vehicle sticker.

(g) It shall be unlawful for any motor vehicle, other than a motor vehicle of the first division, as defined by 625 ILCS 5/1-146, or a motor vehicle of the second division with a B class state license plate, as defined by 625 ILCS 5/1-146 and 5/3-815(a), (collectively an "Approved Vehicle"), to be parked in any municipal parking lot as described in Schedule XII, and no parking permit shall be issued under this Section in relation to a motor vehicle which is not an Approved Vehicle.

(h) It shall be unlawful for any inoperable motor vehicle, as defined by Section 94.04(F)(1) of the Lombard Village Code, to be parked in any municipal parking lot as described in Schedule XII, and no parking permit shall be issued under this Section in relation to any such inoperable motor vehicle.

(i) Except in regard to the special Village Parking Lot A and North Broadway Avenue parking lot, as referenced in Schedule XII (a), it shall be unlawful to park any motor vehicle within any municipal parking lot as described in Schedule XII at any time between the hours of 2:00 a.m. and 5:00 a.m., after snow begins to fall, if the snow within the municipal parking lot is one (1) inch or more in depth, as determined by the Director of Public Works or his representative. The Director of Public Works, or his representative, shall immediately notify the media and Police Department when he determines that snow within any municipal parking lot is one (1) inch or more in depth.

Section 10-13-23 Parking for Persons with Disabilities

Section 10-13-23.1 Definition

(a) "Person with disabilities," when used in Sections 10-13-23.1 through 10-13-23.3, shall mean a person that has been issued Illinois vehicle registration plates pursuant to 625 ILCS 5/3-609 or 5/3-616 or a person who meets the definition of a person with disabilities as defined in 625 ILCS 5/1-159.1.

(b) "Authorized holder," when used in Sections 10-13-23.1 through 10-13-23.3, shall mean an individual issued a disability vehicle registration plate pursuant to 625 ILCS 5/3-616, an individual issued a disability parking decal or device pursuant to 625 ILCS 5/11-1301.2, or an individual issued a disabled veteran's vehicle registration plate pursuant to 625 ILCS 5/3-609.

Section 10-13-23.2 Persons with Disabilities Exempt from Certain Parking Regulations

(a) A motor vehicle bearing vehicle registration plates issued to a person with disabilities pursuant to 625 ILCS 5/3-616, or to a disabled veteran pursuant to 625 ILCS 5/11-609, or a special decal or device issued pursuant to 625 ILCS 5/3-616 or 5/11-1301.2, or a motor vehicle registered in another jurisdiction upon which is displayed a vehicle registration plate, special decal, or device issued by the other jurisdiction designating that the vehicle is operated by or for a person with disabilities, shall be exempt from the payment of parking meter fees and exempt from any statute or ordinance imposing time limitations on parking except limitations of one-half hour or less, on any street or highway zone, or any parking lot or parking place which is owned, leased, or owned and leased by the Village or a municipal parking utility; but such vehicle shall be subject to the laws which prohibit parking in "no stopping" and "no standing" zones in front of or near fire hydrants, driveways, public building entrances and exists, bus stops, and loading areas; subject to the following:

1. Such a vehicle is prohibited from parking where the motor vehicle constitutes a traffic hazard, whereby the motor vehicle shall be moved at the instruction and request of a law enforcement officer to a location designated by the officer.

2. Any motor vehicle bearing vehicle registration plates or a special decal or device specified in this subsection (a) or such devices the Village deems proper as evidence that the vehicle is operated by or for a person with disabilities or disabled veteran may park, in addition to any other lawful place, in any parking place specifically reserved for such vehicles, by the posting of an official sign as provided by 625 ILCS 5/11-301.

3. Parking privileges granted by this subsection (a) are strictly limited to the person to whom the special vehicle registration plates, special decal, or device were issued and to qualified operators acting under said person's express direction while the person with disabilities is present.

4. A person to whom privileges were granted pursuant to this subsection (a) shall, at the request of a police officer or any other person invested by law with authority to direct, control, or regulate traffic, present an identification card with a picture as verification that the person is the person to whom the special vehicle registration plates, special decal, or device was issued.

5. Parking privileges granted by this subsection (a) are also extended to motor vehicles of not-for-profit organizations used for the transportation of persons with disabilities when such motor vehicles display the decal or device issued pursuant to 625 ILCS 5/11-1301.2.

(b) Except as permitted by subsection (a) above, no person shall use any area for the parking of any motor vehicle pursuant to Section 10-13-1 of this Traffic Code, or where an official sign controlling the area expressly prohibits parking at any time or during certain hours.

Section 10-13-23.3 Unauthorized Use of Parking Places Reserved for Persons with Disabilities

(a) It shall be unlawful to park any motor vehicle which is not bearing registration plates or decals issued to a person with disabilities, as defined by 625 ILCS 5/1-159.1, pursuant to 625 ILCS 5/3-616 and/or 5/11-1301.2, or to a disabled veteran pursuant to 625 ILCS 5/3-609, as evidence that the vehicle is operated by or for a person with disabilities or disabled veteran, in any parking place, including any private or public off-street parking facility, specifically reserved, by the posting of an official sign as designated pursuant to 625 ILCS 5/11-301, for motor vehicles displaying such vehicle registration plates or decals. Any motor vehicle bearing a person with disabilities vehicle registration plate or person with disabilities parking decal or device containing the international symbol of access issued to persons with disabilities by any local authority, state, district, territory, or foreign country shall be recognized by the Village as a valid vehicle registration plate or device and receive the same parking privileges as residents of the State or Village.

(b) Any person or local authority owning or operating any public or private off-street parking facility may, after notifying the Police Department, remove or cause to be removed to the nearest garage or other place of safety any vehicle parked within a stall or space reserved for use by persons with disabilities which does not display registration plates for a person with disabilities, or a special decal or device as required under this Section.

(c) An individual with a vehicle bearing disability vehicle registration plates or a parking decal or device issued to a qualified person with a disability under 625 ILCS 5/3-616 or 5/1301.2, or to a disabled veteran pursuant to 625 ILCS 5/3-609, shall be in violation of this Section if: (1) the person using the disability

vehicle registration plate or parking decal or device is not the authorized holder of the disability vehicle registration plate or parking decal or device or is not transporting the authorized holder of the disability vehicle registration plate or parking decal or device to or from the parking location; and (2) the person uses the disability vehicle registration plate or parking decal or device to exercise any privileges granted through the disability vehicle registration plate or parking decals or devices under this Traffic Code or the Illinois Vehicle Code.

(d) It shall not be a defense to a charge under this Section that either the sign posted pursuant to this Section or the intended accessible parking place does not comply with the technical requirements of 625 ILCS 5/11-301, the Illinois Department of Transportation regulations, or regulations of the Village, if a reasonable person would be made aware by the sign or notice on or near the parking place that the place is reserved for a person with disabilities.

(e) That those locations, as set forth in Schedule XVII, attached hereto and made part hereof, are specifically designated as parking spaces for persons with disabilities

Section 10-13-23.4 Penalty

(a) Any person who violates Section 10-13-23.3(a) above shall be fined two hundred fifty and no/100 dollars (\$250.00) in addition to any costs or charges connected with the removal or storage of any motor vehicle authorized under Section 10-13-23.3(b) above.

(b) Any person who violates Section 10-13-23.3(c) above shall be fined five hundred and no/100 dollars (\$500.00) in addition to any costs or charges connected with the removal or storage of any motor vehicle authorized under Section 10-13-23.3(b) above.

Section 10-13-24

(A) It shall be unlawful for any motor vehicle other than a motor vehicle of the first division, as defined by 625 ILCS or a motor vehicle of the second division with a B class state license plate, as defined by 625 ILCS 5/1-146 and 5/3-815(a), to be in any municipal parking lot as described in Schedule XXIII.

(B) It shall be unlawful to park any motor vehicle within any municipal parking lot as described in Schedule XXIII at any time between the hours of 2:00 a.m. and 5:00 a.m., after snow begins to fall, if the snow within the municipal parking lot is one (1) inch or more in depth, as determined by the Director of Public Works or his representative.

The Director of Public Works, or his representative, shall immediately notify the media and Police Department when he determines that snow within any municipal parking lot is one (1) inch or more in depth.

ARTICLE XIV - MISCELLANEOUS PROVISIONS

Section 10-14-1 Regulations Established in Certain Non-Village Owned Parking Lots Relative to the Use of, Parking within and Traffic within said Parking Lots.

A. Pursuant to Ill. Rev. Stat. ch. 95 1/2, section 11-209, the Village has entered into Agreements, adopted pursuant to Ordinance, with the owners/managing agents of the following described non-village owned parking lots:

wherein some or all of the following regulations have been established relative to the use of, parking within and traffic within said parking lots:

1. Permanent stop signs shall be posted at various locations within said parking lots as more fully set forth in the above listed ordinances, and the driver of a motor vehicle coming upon any stop sign within said parking lots, shall first come to a complete full stop at such sign prior to proceeding.
2. Where the parking lot is associated with a shopping center, no motor vehicle shall be stopped or parking on the roadway or driveway which lies directly in front of the stores located within said shopping center.
3. The stopping, standing or parking of a motor vehicle within the parking lot in any area designated by sign to be a no parking zone, including, but not limited to, the stopping, standing or parking of a motor vehicle in any designated fire lane or within fifteen (15) feet of any fire hydrants, wall hydrants, water standpipes or fire exist doors, shall be prohibited.
4. The stopping, standing or parking of commercial vehicles (vehicles of the second division as defined by Ill. Rev. Stat., ch. 95 1/2, other than recreational vehicles), which are required to have other than a Class B State of Illinois license plate as defined by Ill. Rev. Stat., ch. 95 1/2, section 3-815, within the parking lot, other than temporarily for such time as is necessary for the reasonably expeditious loading and/or unloading of said vehicles when making pick-ups and/or deliveries to a tenant of or business within any building associated with said parking lot, or the owner of said parking lot, shall be prohibited.
5. No motor vehicle shall be so operated as to cause or produce unnecessary loud, raucous, excessive or unusual noises, by the playing of vehicle radio, or by the racing of the motor, or by lack of muffler or use of a muffler cutout, by tire friction upon rapid turning or weaving, or by spinning of wheels from standing or slow moving position produced by sudden unnecessary acceleration, or by continuous unnecessary sound of a horn or other noise or signal device, or by the running of refrigeration units or compressors on said motor vehicle.
6. The stopping, standing or parking of a motor vehicle within any designated handicapped parking area, without the property display of the handicapped status of the occupant of said motor vehicle by way of either special State of Illinois license plates or a locally issued handicapped status placard, shall be prohibited.
7. The stopping, standing or parking of a motor vehicle within five hundred (500) feet of any fire, police or other emergency vehicle that has responded to a call or an alarm shall be prohibited.
8. The operating of unlicensed go-carts, dirt bikes, mini-bikes or other miniature vehicles shall be prohibited.

9. It shall be unlawful for any motor vehicle to be parked, abandoned or remain unattended during a snow storm, flood, fire, or other public emergency, in the parking area, where it constitutes an obstruction to traffic or where stopping, standing or parking is prohibited.

10. It shall be unlawful to offer for sale or sell any beverage, food or merchandise, including but not limited to motor vehicles, campers, motorcycles and boats, within the parking area, absent a special permit issued by the Village authorizing said sale.

11. It shall be unlawful to park any motor vehicle in any place other than a designated parking space.

Signs, pavement markings, fire lanes and no parking zones in relation to the aforementioned regulations are specifically described on Exhibit A attached to each of the aforementioned Ordinances, said Ordinances and Exhibits being made a part hereof by reference.

B. It shall be unlawful for any person, firm or corporation to violate any of the parking lot use, parking or traffic regulations established by this Section and the Ordinance referenced in Subsection A above.

C. Any person, firm or corporation violating the provisions of this Section shall be fined not less than TWENTY-FIVE AND NO/100 DOLLARS (\$25.00), {except that violations of Subsection A(6) above, in regard to handicapped parking, shall be subject to a minimum fine of FIFTY AND NO/100 DOLLARS (\$50.00)} nor more than FIVE HUNDRED AND NO/100 DOLLARS (\$500.00).

Section 10-14-2 Skateboarding, Roller Skating, In-Line Skating (Roller Blades) and Scooters in a Business District.

(a) No person shall ride a skateboard or scooter, or use roller skates or in-line skates (roller blades), or use a similar device upon any public right-of-way (including, but not limited to, a public street or sidewalk or upon a public parking or loading area) within a Business District as defined in Section 10-1-1 above, provided signs or markings so prohibiting such activity are present;

(b) Any person found to be in violation of this Section shall be fined not less than twenty-five and no/100 dollars (\$25.00) nor more than seven hundred fifty and no/100 dollars (\$750.00).

Section 10-14-3 Right Turn on Red Traffic Signals. It shall be unlawful to make a right turn on a red traffic signal at those locations where said right turn on a red traffic signal is prohibited, as set forth in Schedule XIII attached hereto and made part hereof.

Section 10-14-4 No Left Turn. It shall be unlawful to make a left turn at those locations where said left turn is prohibited, as set forth in Schedule XIV attached hereto and made part hereof.

Section 10-14-5 No Right Turn. It shall be unlawful to make a right turn at those locations where said right turn is prohibited, as set forth in Schedule XV attached hereto and made part hereof.

Section 10-14-6 School Zones. For purposes of limiting the speed of motor vehicles traveling through the locations as set forth in Schedule XVI attached hereto and made part hereof are hereby designated as school zones.

Section 10-14-7 No U-Turn. It shall be unlawful to make a U-turn at those locations where a U-turn is prohibited, as set forth in Schedule XVIII attached hereto and made part hereof.

ARTICLE XV-SIZE, WEIGHT, LOAD

Section 10-15-1 No Truck Streets

(a) Definition. For the purpose of this Ordinance, the following terms, phrases, words, and their derivations shall have the meanings given herein. When not inconsistent with context, words used in the present tense include their future, words in the plural include the singular number, and words in the singular number include the plural number. The word "shall" is always mandatory, and not merely directory.

(1) "Village" is the Village of Lombard; Section 10-15-2 Spilling loads on highways prohibited

(2) "Truck" is any vehicle designed, maintained, or operated for the transportation of property, and which vehicle carries a Class "D" license plate or higher designation from the State of Illinois, or its equivalent from any foreign State of jurisdiction.

(3) "Residential Streets" are those streets in Lombard predominantly of a residential character, and are all streets not identified in subparagraph (4).

(4) "Truck Routes" are those streets identified as below:

- (a) Butterfield Road;
- (b) Finley Road South of Roosevelt Road;
- (c) Highland Avenue South of Butterfield Road;
- (d) North Avenue;
- (e) Roosevelt Road;
- (f) Route 53;
- (g) St. Charles Road; and
- (h) 22nd Street.

(B) Application of Regulation. All trucks within the Village shall not operate on residential streets, but on truck routes.

(1) Exceptions. This Ordinance shall permit:

- (a) Emergency Vehicles. The operation of emergency vehicles upon residential streets;
- (b) Public Utilities. The operation of trucks owned or operated by the Village public utilities, or any contractor or material men

while engaged in the repair, maintenance, or construction of streets, Village improvements of street utilities within the Village;

(c) Local Destination or Origination. The operation of trucks upon residential streets where necessary to the conduct of business at a destination or origination point within those residential streets.

(d) Detoured Truck. The operation of trucks upon any officially-established detour in any case where such trucks could lawfully have operated upon the street for such detours established; and,

(e) School Buses and Public Buses.

(C) Enforcement.

(1) The Village Clerk shall keep and maintain accurate maps setting out where truck traffic is limited through the Village of Lombard.

(2) The maps shall be kept on file in the office of the Village Hall, and shall be made available to the public;

(3) The Director of Public Works maintains signs. The Director of Public Works of the Village shall cause all streets upon which truck traffic is limited to be clearly posted to give notice that this Ordinance is in effect.

(a) Failure to post. No person shall be charged with violating the provision of this ordinance by reason of operating a truck on a street wherein truck traffic is prohibited unless appropriate signs are posted on such street.

(D) Penalty. Any violation of this Ordinance shall be punishable by a fine of not less than fifty (\$50.00) dollars and not to exceed five hundred (\$500.00) dollars for the first offense. Persons having been convicted of this a second time shall be fined not less than one hundred (\$100.00) dollars nor more than five hundred (\$500.00) dollars.

Section 10-15-2 Limited Load Streets

No vehicles having a weight in excess of five (5) tons shall be allowed to operate on any residential street, or street listed in Schedule XIX-Limited 5 Ton Load. Posting of the street limiting the loads to 5 tons shall be required prior to prosecution.

1. Exceptions: Five (5) ton limit shall not apply to:

a. Emergency vehicles

b. School buses and public buses

c. Public utilities-the operation of trucks owned or operated by the Village Public Works Department,

or any contractor or material-men while engaged in the repair, maintenance or construction of streets, Village improvements or street utilities within the Village of Lombard and on behalf of the Village of Lombard

- d. Local destination or origination-the operation of trucks upon residential streets where necessary to the conduct of business at a destination or origination point within those residential streets

The exceptions shall allow the above listed vehicles to use residential streets or streets listed in the schedule, but only for the shortest limited distance on the streets to accomplish the purpose. The exception shall not apply when any vehicle has an alternative means of access which could be used and does not involve a residential street or street on the schedule.

Section 10-15-3 Limited Load Bridges

No vehicles having a weight in excess of the following limits shall be allowed to operate on the Hill Avenue Bridge over the east Branch of the DuPage River:

Single Unit Vehicle	Twelve (12) tons
Combination Vehicles with Three (3) or Four (4) Axles	Fourteen (14) tons

ARTICLE XVI - BICYCLES

10-16-1 Application of Rules

- (a) Any person, firm or corporation violating any provisions of this Article where no other penalty is provided shall be fined no less than thirty-five and no/100 dollars (\$35.00) nor more than seven hundred fifty and no/100 dollars (\$750.00).
- (b) The parent of any child, and the guardian of any ward, shall not authorize or knowingly permit any such child or ward to violate any of the provisions of this Article.
- (c) The regulations applicable to bicycles, as set forth in Chapter 11, Article XV of the Illinois Vehicle Code, as adopted by reference pursuant to Section 10-19-1 below, shall apply whenever a bicycle is operated upon any highway or upon any path set aside for the exclusive use of bicycles subject to those exceptions set forth in said Chapter 11, Article XV of the Illinois Vehicle Code.

ARTICLE XVII – (RESERVED)

ARTICLE XVIII - ENFORCEMENT, PENALTIES

Section 10-18-1 Penalty

Any person, firm or corporation violating any provision of this Lombard Traffic Code, where no other penalty is provided, shall be fined not less than thirty-five and no/100 dollars (\$35.00) nor more than seven hundred fifty and no/100 dollars (\$750.00) for each offense.

ARTICLE XIX - RULES OF THE ROAD

Section 10-19-1

ADOPTION OF THE ILLINOIS VEHICLE CODE

There is hereby adopted for the purpose of prescribing regulations for pedestrians and the operation of vehicles on the Village streets, certain codes known as the Illinois Vehicle Code, being in particular Act 5 of Chapter 625 of the Illinois Compiled Statutes respectively, one (1) copy of which code has been on file for at least thirty (30) days prior to the adoption of this Section, and now is filed, in the office of the Village Clerk, and the same is hereby adopted and represented as fully as if set out at length herein, and the provisions thereof shall be controlling within the limits of the Village. Notwithstanding the foregoing, 625 ILCS 5/11-1006(c) is not adopted by reference, and the provisions thereof shall not be subject to enforcement as a Village ordinance violation pursuant to this Section 10-19-1. For purposes of citing persons for violations of the Illinois Vehicle Code, as adopted by this section, a reference to that portion of the Illinois Compiled Statutes section number listed after the slash mark, preceded by the letter 'V' shall be used, (Example 625 ILCS 5/11-601 shall be referenced as V11-601), and the local ordinance violation box on the Uniform Traffic Citation shall be checked.”

Section 10-19-2

PENALTIES FOR VIOLATIONS

Except as provided elsewhere in this Lombard Traffic Code, for all Illinois Vehicle Code violations written as local ordinance violations pursuant to Section 10-19-1 above, except those where a minimum fine is otherwise specified by State statute, the fine shall be not less than seventy-five and no/100 dollars (\$75.00) and not more than seven hundred fifty and no/100 dollars (\$750.00), exclusive of court costs and fees, except that speeding violations shall be subject to the following minimum fines:
