**ORDINANCE 7701**

**AN ORDINANCE CORRECTING A SCRIVENER'S ERROR  
RELATIVE TO ORDINANCE NO. 7318, ADOPTED JANUARY 5, 2017,  
IN REGARD TO CHAPTER 155, OFF-STREET PARKING AND LOADING,  
ACCESSIBLE PARKING REQUIREMENTS**

WHEREAS, the Village of Lombard maintains a Zoning Ordinance which is found in Title 15, Chapter 155 of the Lombard Code; and,

WHEREAS, on December 12, 2016, pursuant to proper notice, the Lombard Plan Commission held a public hearing relative to amending the Off-street Parking and Loading, Accessible Parking Requirements for all zoning districts, as set forth in the Lombard Zoning Ordinance, to delete (1) Size, (2) Number including Table 6.1, (3) Access and (4) Identification located in Section 155.602(B) in order to reference the Illinois Accessibility Code exclusively; and,

WHEREAS, the Lombard Plan Commission recommended the deletion of (1) Size, (2) Number including Table 6.1, (3) Access and (4) Identification being part of Section 155.602(B) to the Village Board; and,

WHEREAS, the Village Board approved the recommendation to delete (1) Size, (2) Number including Table 6.1, (3) Access and (4) Identification of Section 155.602(B) on January 5, 2017 from the Lombard Zoning Ordinance ("Ordinance No. 7318"); and,

WHEREAS, as part of the adoption of Ordinance 7318 on January 5, 2017, the signed version of Ordinance 7318 does not represent the draft version that was presented to the Lombard Plan Commission and the Village Board for consideration (the scrivener's error); and,

WHEREAS, to properly correct the omissions, Lombard Village Code should be amended to reinstate the subsection as approved.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

**SECTION 1:** That Title 15, Chapter 155, Section 155.602(B)(2) of the Lombard Village Code is hereby amended to read as follows:

(B) Accessible parking requirements. Accessible (handicapped) parking spaces shall be provided in compliance with the Illinois Accessibility Code.

**SECTION 2:** That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
