Park Avenue Patio FAQ

What is Park Avenue Patio?

Lombard's Park Avenue Patio is a space designed for consuming purchased to-go food and beverages from local restaurants, while remaining in compliance with the State's COVID-19 Phase 3 regulations. The Patio is located on S. Park Ave., between St. Charles Rd. and Michael McGuire Drive and will be available Fridays, 3 – 10 p.m., and Saturdays – Sundays, 11 a.m. – 10 p.m. Tables will be provided by the Village of Lombard. Restaurants cannot serve to people in the Patio.

Will alcohol be allowed in Park Avenue Patio?

Alcohol consumption is limited to beverages purchased to-go from local restaurants or tavern liquor license holders.

Who can use the Park Avenue Patio?

Park Avenue Patio is for customers of Lombard restaurants that have purchased food or packaged drinks to go. Please act responsibly and courteously so we can continue to provide access to Park Avenue Patio.

What are the rules of Park Avenue Patio?

- MAINTAIN SOCIAL DISTANCE OF 6' BETWEEN YOURSELF AND PEOPLE OUTSIDE OF YOUR HOME
- Order food or packaged drinks ahead of time for pick up/carry out. Maintain social distance while waiting for food and follow restaurant guidelines.
- Per requirements of the IDPH, a mask that covers your nose and mouth must be worn when you are not eating or drinking.

What is NOT allowed in the Park Avenue Patio?

- NO Smoking
- NO Standing/loitering
- NO Violation of social distancing
- NO groups of more than 6
- NO tents or chairs
- NO consumption of alcohol outside of to-go alcohol purchased from local restaurants

What if I need to use the bathroom?

Public bathrooms will not be available. Please respect businesses and their bathroom use restrictions. It is recommended that the public plan ahead and use their own facilities before leaving home.

Who will be maintaining Park Avenue Patio?

Park Avenue Patio is managed by the Village of Lombard. The area will be under surveillance by the Lombard Police Department for the purposes of general safety and theft prevention. Additionally, the Village has hired a third-party company to help keep tables clean.

What can citizens do to make sure that this program is successful?

Visitors to Park Avenue Patio are reminded to maintain social distance and to act responsibly. If proper behavior is not practiced, it is always possible that the State may place unwanted restrictions on the Village in the name of public health and safety.

Is the Village open to suggestions or modifications of this concept moving forward?
